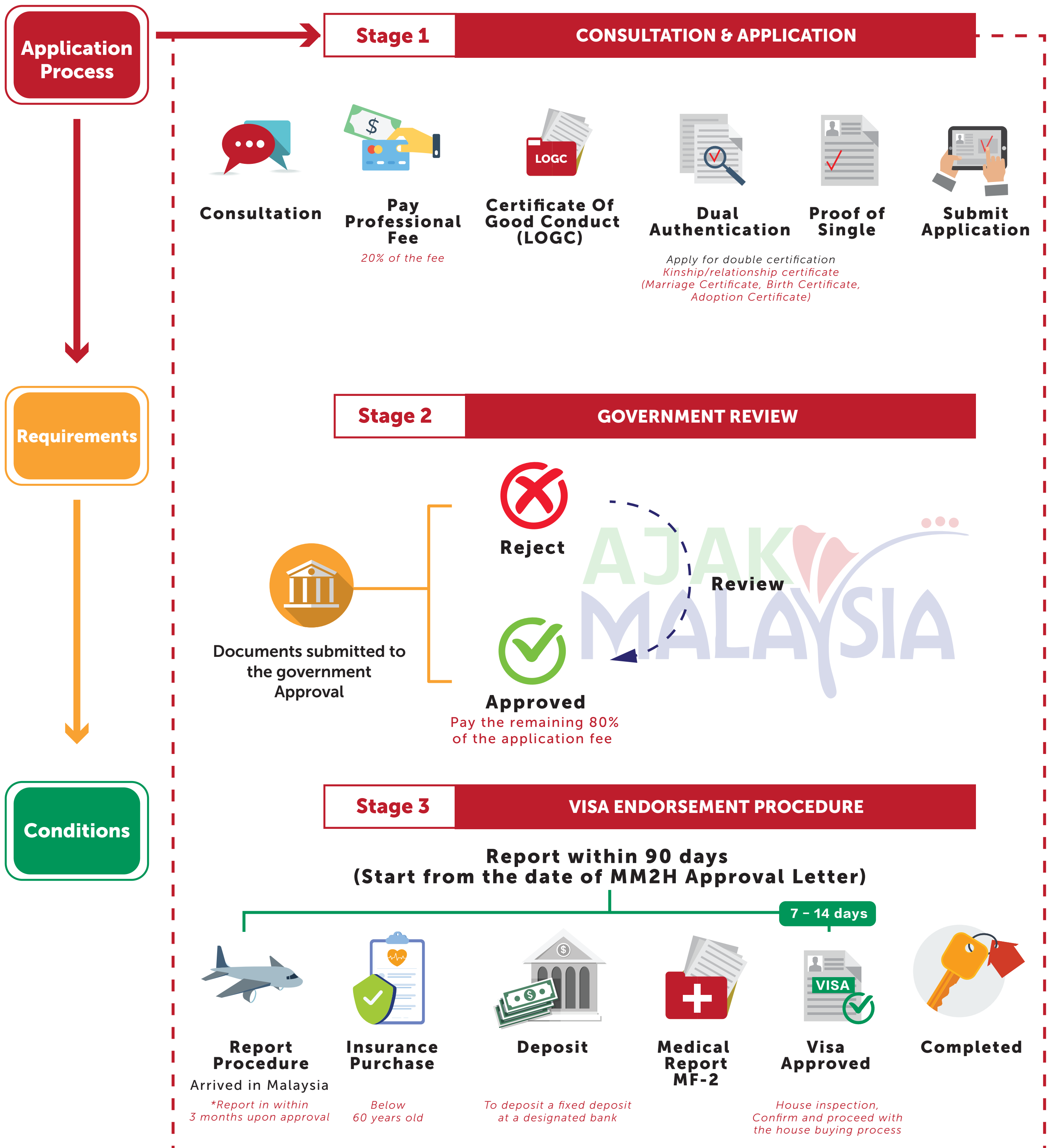

All documents to be prepared before submission

- 1** Latest copy of principal applicant's passport (biodata page)
- 2** Latest copy of principal dependent's passport (biodata page)
- 3** Each applicant to provide 4 passport-sized photos (blue / white background)
- 4** Certificate Of Good Conduct (LOGC) / Police Certificate / Certificate Of Clearance – Participants, Aged 18 years and above
Must be in English, translated by the authorised translator Appointed by Participant's Government / Embassy and has to be certified by Malaysian Embassies / High Commissioners / Consulate or at the Ministry of Foreign Affairs Malaysia.
- 5** Proof of Kinship
(Such as: Marriage Certificate, Birth Certificate, Adoption Certificate)

- 6** Application letter from the principal and resume



Documents Required After Approval



- 1** Approved participants and dependants must possess valid Medical Insurance coverage (Participants aged 60 and below)
- 2** Medical Report (MF II FORM)
After approved, submit report from any Registered Clinic / Hospital in Malaysia
- 3** Certificate copy of Fixed Deposit Statement (FD) & Purchase Of Property
(Within 1 Year of Visa Endorsement after MM2H Visa is approved)

To Endorse MM2H Visa within 90 days from date of MM2H approval letter
